PLEASE READ CAREFULLY!

TO: The Play Lounge Inc., its agents, owners, officers, affiliates, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter referred to as "The Play Lounge"):

IN CONSIDERATION OF The Play Lounge allowing the participant(s) named below to use the facility or to participate in any parties or activities at/by THE PLAY LOUNGE (hereinafter referred to as the "Activities"), the undersigned agrees as follows:

1. I, for myself, my child/children or ward/wards acknowledge and understand that there are dangers and risks associated with the activities at/by THE PLAY LOUNGE and agree to assume all risk of personal injury, including the potential for paralysis and death. I, for myself, my child/children or ward/wards agree to follow the safety instructions provided by THE PLAY LOUNGE on its website, posted in its facility or otherwise and acknowledge that failure to do so may result in expulsion from THE PLAY LOUNGE.
2. I, for myself, my child/children or ward/wards, and on behalf of my or their heirs, assigns, personal representatives and next of kin, HEREBY HOLD HARMLESS THE PLAY LOUNGE its owners, directors, officers, employees, volunteers, lessors, equipment manufacturers and sponsoring agencies (collectively referred to herein as the "Releasees") from all liability for any such personal injury, disability, death or loss or damage to person or property that I or my child/children or ward/wards may suffer as a result of my participating in Activities DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT, R.S.O. 1990, c. O. 2 ON THE PART OF THE PLAY LOUNGE AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE PLAY LOUNGE TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE PLAY LOUNGE INC. ACTIVITIES.
3. I, for myself, my child/children or ward/wards, will indemnify, save and hold harmless each of the Releasees from any such claims, expenses, legal fees, loss, liability, damage, or cost which relates to, or arises from any matter dealt with under this Waiver, to the fullest extent permitted by law.
4. I represent that the participant(s) named below are healthy and physically able to participate in the Activities.
5. I, for myself, my child/children or ward/wards, understand that my execution of this Waiver on or prior to the initial visit will authorize THE PLAY LOUNGE to enter this Waiver into its database and use it as a continuous, multi use waiver for my child's/children's or ward's/wards' ongoing participation in the activities or use it as a waiver executed for my other child/children or ward/wards.
6. I hereby expressly authorize THE PLAY LOUNGE to use this Waiver as a multi use waiver until such time as I revoke it in writing.
